



## Additional Fees for Student Support Services

As a responsibly inclusive school, ICS Addis recognizes that we have an ethical responsibility to support the students we admit. In order to provide a high quality program, ICS charges additional fees for specialized educational services provided by the Student Support Team. These fees are in place to help offset the cost of providing a wide range of specialized supports across all grades. These fees are not designed to cover the full cost of the additional services.

ICS reserves the right to review the continued enrollment of any students receiving Student Support Services. If at any point the school determines that it no longer has appropriate services to support the academic and social-emotional success of the student, ICS may discontinue the student's enrollment. Parents will be notified in a timely manner of any decisions regarding continued enrollment.

Fees and services are not negotiable and may not be waived. ICS makes all final decisions regarding the need for services and the level of services needed. If ICS determines that a student needs services to be successful, the services, assessments and payment are required for a student to be enrolled at ICS.

The middle and high school STEP Programs can incur additional separate fees for extra programs which will also be invoiced to the parents by the Business Office. The extra programs recommended will be agreed upon in the student's Individual Learning Plan (ILP). If payments for the extra programs are declined by the parents, the additional programs will not be provided.

<i>Assessments include speech and language, occupational therapy and educational psychologist evaluations. If the assessment determines that a fee-paying service is needed, the assessment payment is credited toward the cost of the service.</i>

**Billing Information**

STEP Program fees are billed annually. Speech and language therapy and occupational therapy are billed by the semester (two semesters per year). Bills for the assessments will be issued when parents have consented to the assessment..

Any additional fees for new or returning students will be added to the tuition and fees invoice. Additional fees for new students are based on application documents and information gathered during the admissions process.

If ICS determines that a student does not need services, after the family has paid for the services, ICS may issue a refund for the fees paid, at the school's discretion.
